On scrutiny of the proposal, it is found that the Personnel as given in annexure-1 are only eligible to be the faculty and hence their names are approved tentatively.

### Subject to following conditions

- a) They should be replaced or confirmed as the case may be following the procedure of constituting selection committee for appointment involving Society Members, subject experts and following normal procedures for selection in vogue like calling for candidates for each post from news paper advertisement etc., giving sufficient time for candidates to apply and conducting interview etc. Minutes of the Selection Committee proceedings, Newspapers advertisement, list of candidates applied to be submitted alongwith proposal for approval of staff to SCERT in future.
- b) The condition of recognition for D.Ed course should be followed as given in recognition orders for these courses.
- c) If for any reason, the staff earlier approved for B.Ed/M.Ed. course by the University authorities concerned are shifted to D.Ed. courses and got approval now for D.Ed course, the management is requested to select and appoint suitable personnel as per norms for these courses B.Ed./M.Ed. and obtain approval by the competent authority of University concerned at the earliest. Similarly, if the management has shifted the personnel from LPT faculty available in the institution to D.Ed, they should select and appoint suitable personnel as per norms for LPT, course and obtain approval of Director, SCERT at the

- d) All original certificates of full time staff of all courses should be produced during visits of visiting teams/or as and when asked by the competent approving authority.
- e) If any approved candidate leaves the institution on resignation or for any other reason, the matter should be brought to the notice of the undersigned within a week. The vacancy so arisen should be filled in within two months following the usual procedure including the approval of the Director, SCERT.
- f) If it is detected in future that the present approval of staff is got on producing some false information, the personnel / Management shall be liable for any actions that would be deemed fit by the undersigned besides canceling the approval now given.
- g) Personnel now approved have to have proficiency in Telugu / Hindi / Urdu language according, as medium of instruction offered by the institution concerned. As such they should pass Telugu / Hindi / Urdu Language. Departments test (as the case may be) (Higher standard) conducted by APPSC in the immediate next turn if they have not studied Telugu / Hindi / Urdu upto class XII as a subject.
- h) If, any posts not covered in Annexure I appended herewith the management should be submitted proposals duly following procedure as laid down in the G.O. Rt. No. 39 Edn. dated 18.1.2007 with in a month for filling up the vacant post / posts.
